RULES

You have applied for an accreditation as a press photographer. On arrival on the site, you need to make you known to the official in charge of access control.

You have previously provided the ATD organizer:

- An approved and signed application for certification
- The letter of cancellation and discharge approved and signed legibly
- This approved and signed rules
- Annex 1 approved and signed
- A letter signed by your employer attesting to cover you in civil responsibility for your work or failing a photographer insurance "Civil Responsibility" for your performance of photographer

A chasuble "Photographer" numbered will be assigned in exchange of an ID. This chasuble will necessarily be returned at the end of the week end, including for photographers with a yearly certification.

The provision of a chasuble "Photographer" implies your presence at the briefing of the organization held on Saturday and Sunday morning.

Wearing a chasuble "Photographer" is an intangible prior to access the "Photographers" area.

The chasuble has to be worn over your clothes; it may be attached to a bag or belt. It can not in any way be used by a person other than yourself.

The area dedicated to accredited photographers is defined on the plan. Access to safety areas is completely forbidden. The presence in some areas (for example between the lines upstream of the Christmas tree) should be subject to approval of the head of track and can only be punctual.

In the booked photographers areas, you must wear closed shoes. The Hearing protection is highly recommended.

The presence in the "Photographers" area involves the realization of shots; it is not a "spectator" space. When shooting, be careful not to cause discomfort to other photographers or videographers, officials and competitors

Safety is the primary concept. Be responsible and professional in responding positively and immediately to requests from officials. Pay attention to yourself and to others. Stay constantly on alert over your environment.

Failure of this regulation, refusal of compliance with an official or any other major event will lead to appropriate sanctions, including possible withdrawal of accreditation, the exclusion of the site and the refusal of any new application accreditation.


